

# ESD 112 Board of Directors Business Meeting

August 27, 2024

#### **ROLL CALL**

## CALL TO ORDER

The ESD 112 Board of Directors Business meeting was called to order by LeAnne Bremer, *Vice-President*, at 3:02 pm on August 27, 2024. A quorum of four members was present. Mark Hottowe joined the meeting at approximately 3:30 pm and participated in the policy first reading and board action discussions.

## **REPORTS AND DISCUSSION**

- <u>Tour of Florens Academy:</u> Superintendent Tim Merlino shared an overview of the work required to open the Florens Academy. He commended the ESD 112 facilities team, human resources department, and Specialized Student Services administrators for their combined efforts to open the new facility. Jeffrey Niess, *Executive Director of Specialized Student Services*, introduced Dr. Joshua Fritts, *Director of Therapeutic Programs*, and Ashley Bloodworth, *Florens Academy Director*, who provided a tour of the Florens Academy.
- <u>Program Highlight: ESD 112 Therapeutic Learning Programs</u>: Dr. Joshua Fritts, *Director of Therapeutic Programs*, shared an overview of the ESD 112 therapeutic behavioral health programs:
  - The Curae Center is located in Camas and supports students grades K-5 in a day treatment setting. The program combines academic and behavioral interventions tailored to each student's individualized education plan (IEP).
  - The Florens Academy is a day school program for students with significant developmental and communication delays requiring intensive behavioral support beyond that of a traditional life skills classroom and caters to students needing 1:1 or 2:1 staff support due to struggles with aggression and/or self-injurious behaviors. The program is located on the ESD 112 main campus in Vancouver.
  - Students in grades K-8 who need behavioral interventions and reside in Klickitat and Skamania Counties, attend the Gorge Academy in White Salmon. The program emphasizes emotional, academic, and social development.
  - The Spero Center provides a nurturing, therapeutic educational environment for students in grades 6-12 whose mental health challenges affect their school attendance. The Spero Center is located on the ESD 112 main campus in Vancouver.
  - The Quest Academy provides a supportive, therapeutic learning environment for students in grades K-12 residing within Cowlitz County who require behavioral interventions to access their education.

- <u>Early Head Start & ECEAP Monthly Report:</u> Jodi Wall, *Executive Director of Early Care & Education*, shared highlights of this month's report. Yesterday, 160 child care staff attended preservice training at the ESD. The feedback from staff was very positive. Next Thursday is the first day of school for most programs. ECE was awarded a grant for health and safety upgrades to the Park Crest and Hough Early Learning Centers.
- <u>First Reading of Revised and New Policies:</u> Marnie Allen, *Assistant Superintendent of Human Resources, and Insurance Programs*, reviewed proposed changes to ESD 112 policies and the new policies listed below.

- <u>Superintendent's Report</u>: Tim Merlino, *Superintendent*, briefed the board on the following:
  - <u>Hiring Update</u>: Tim commended the human resources team for their work this summer hiring more than ninety new employees.
  - <u>AESD Retreat</u>: Superintendent Merlino and Gavin Hottman, *Chief Business Officer*, attended the AESD Retreat in the Tri-Cities. There was a focus on districts that are struggling financially and how to recruit qualified professionals to work in school finance.
  - <u>Safety Net Award</u>: The ESD will be awarded \$3,742,674 in funding which was 98% of the original request.
  - <u>Roosevelt School District</u>: Erin Lucich will serve as a part-time superintendent this school year for Roosevelt School District. IT staff are also helping to update the district's technology infrastructure.
  - <u>Board Vacancy Timeline</u>: Two options were presented for consideration for filling the board vacancy.
- <u>Employee Acknowledgements & Recognitions</u>: Monique Dugaw, *Executive Director of Communications & Public Relations,* recognized Laura Martin, D'Ann Monge, and Jessica Armistead.
